Letter from the Executive Director

If someone were to ask me what we do at Bloom every day, I would tell them, "We create the future." We provide children with the confidence, social skills, and academic foundation upon which their future learning depends.

We prepare the workforce of tomorrow, while allowing parents to participate in today's workforce and build a better, more financially stable future for themselves and their families.

With this two-generation strategy, we lift families out of poverty and foster a more prosperous, engaged community. Economist Art Rolnick, formerly of the Minneapolis Federal Reserve Bank, found that every \$1 invested in early education for an economically disadvantaged child returns \$16 to society. Children who show up ready to learn in kindergarten do well all through school and beyond to become more productive workers and engaged members of the community.

2015 Achievements Highlights



BLOOM GOAL: Apply proven best practices in early childhood development and kindergarten readiness to produce exceptional outcomes for children.

In 2015, we served 76 children and their families. Individual assessments of each child demonstrate that they all are performing at or above developmentally-appropriate standards.



BLOOM GOAL: Create a language-rich environment to promote early literacy.

In 2015, we instituted a new classroom literacy program with 9 volunteers committed to reading weekly with our children as part of the community-wide Story Time Matters initiative.

BLOOM GOAL: Meeting the needs in our community for high quality, affordable early learning and child care. More than 500 preschool age children in our local area need financial assistance to attend a quality program.

In 2015, we added a new pre-kindergarten classroom, expanding our capacity by 18 seats. 37% of our total enrollment received tuition assistance. Both the pre-K and infant rooms ended the year with a 50:50 ratio of private pay students to students receiving assistance. To further address the unmet need, the Board of Directors adopted a 5-year strategic plan with the ultimate goal of doubling the number of children we serve.

Together, we can achieve even more in 2016!


Transform the lives of economically disadvantaged families and alleviate the unmet need for early learning and child care.



Financial Narrative

Facility Improvements refers to the renovation of space in the lower level of Messiah Church to create our new pre-K classroom. Additionally, we recarpeted and painted the shared space we use for large motor activities.

The Temporarily Restricted Net Assets are donations made to our Shirley Robinson Scholarship Fund. Other sources of tuition assistance include funding from our partners, Caring for Kids Initiative (CfKI) and the Wayzata School District, state scholarships, and Child Care Assistance Program (CCAP) monies. In Hennepin County, there is a two-and-a-half year waiting list for CCAP funds.
