Scholarships:

Anyone in the community may apply for a scholarship at our center.

Scholarships are granted based on financial need and the availability of scholarship monies and space available. For a family to qualify for a scholarship, they need to meet with a case worker from Caring for Kids (CFK) at Interfaith Outreach and Community Partners (IOCP) our local social service agency if they live in the agency's area. Otherwise, Bloom determines eligibility based on the same criteria. The case worker will determine a family's eligibility based on income and determine if the family will have a copay or not. The family is required to meet with the case worker annually to do a scholarship determination form to confirm they are still eligible to receive a scholarship.

For the Pathways II scholarships we award, we confirm that the family meets the requirements set forth in the MDE Scholarship Application. We check with the family that they meet the requirements to be classified as an "A" through the federal USDA food program - meaning they qualify for free lunch. They can also qualify if they receive certain support from the government and have an open and active case number.

We received a Partners For Healthy Kids grant, a program of the Wayzata Public School District, in the amount of \$80,364. This grant was used to scholarship four children for the school year 2022-2023
